# The Episcopal Diocese of Olympia Report of the Standing Committee (2024)

Your Standing Committee of our Diocese of Olympia is privileged to serve with you. Our primary role, when there is a Bishop Diocesan (or a Bishop Provisional, who has been granted ecclesiastical authority by the Diocesan Convention) in office, is to serve as the Bishop's Council of Advice. We are also a compliment of the Bishop's authority notably in matters of diocesan and congregational real estate decisions as well as reviewing and certifying the canonical processes for those in the ordination process. Standing Committees also are asked to give consent regarding any Bishop elected in the Episcopal Church. When the office of Bishop Diocesan (or Bishop Provisional, as above) is vacant for any reason, the Standing Committee serves as the ecclesiastical authority of the diocese. This year, the Standing Committee experienced a transition, as we started this cycle (Oct 2023-Oct 2024) with the Most Rev. Melissa Skelton as our Bishop Provisional, and she stepped down upon the ordination and consecration of The Rev. Philip N. LaBelle on September 14, 2024.

The Standing Committee is thankful for all the people and bodies who worked faithfully through this time of transition, especially the Joint Board, the Search Committee, the Transition Committee, the Diocesan Council, the Diocesan Staff, the Cathedral Staff, and our consultant through the Presiding Bishop's Office, Anne Schmidt, who was assisted by the Rev. Nathan Kirkpatrick, and all others who shared their gifts through this time.

Voted to change the agreement of The Most Rev. Melissa Skelton as Bishop Provisional from .8 FTE to 1.0 FTE in January 2024 and extended her time with us through the ordination and consecration of the next Bishop Diocesan of Olympia on September 14 2024.

With the work of the General Convention Office, organized the request for consents from Bishops and Standing Committees for The Rev. Philip N. LaBelle as the Bishop-Elect of Olympia; a majority of consents were confirmed in July 2024.
